
Thank you for downloading this discussion guide.

CHAPTER ONE


- 1. Chapter One opens three years later. Why do you think DeAndre chose to come back to Java Joes?

CHAPTER TWO


- 1. What do you think of the way

- 4. Discuss Bethany's comment: "But playing a comparison game with pain never seems to end well for anybody. You are fully entitled to feel whatever you'se feeling and so is she. Pain is pain. Hurt hurts. It won't hurt you any less by claiming you have more of it."
- 5. Why do you think Bethany is giving Natassa Mercy's journal now?

- 4. Comment on romance during slavery. How was it similar to romantic relationships today? How was it different?

CHAPTER NINE

- 1. Why do you think Natassa went to St. Anthony's to serve when she knew Janell might show up? Would you have made that same choice? Why or why not?
- 2. Do you agree with how Bethany handled the situation? Why or why not?
- 3. Have you ever made the choice to forgive someone only to find yourself wrapped back up in bitterness? What did you do to get free?
- 4. Why do you think it's important to Natassa to find out who the accomplice was? Why do you think Janell agreed to ask?

CHAPTER TEN

- 1. Though DeAndre still believed in God, "he didn't carry enough faith to share it, to pass it around, and parcel it out." Have you ever felt like DeAndre?
- 2. Why do you think Janell visited DeAndre? Was it just to deliver Natassa's message?

- 5. How do you define justice?

- 1. Did you learn anything about slavery, African culture, or rice cultivation in this chapter? What did you learn?
- 2. What is your impression of Jonah? Of his relationship with Mercy?
- 3. Discuss the practice of owners separating enslaved families. How does this make you feel about the Millers?
- 4. How does Mercy still feel in between two worlds: white and black? Where do you see her struggling with her identity?
- 5. What are your thoughts regarding Isaac's preaching? What did he emphasize of the nature and character of God?

CHAPTER THIRTEEN

- 1. In this chapter, Natassa prays an angry prayer for God to protect her car. Have you ever prayed an angry, honest prayer? How do you feel God responded?

- 3. Why do think knowing the accomplice's name doesn't satisfy Natassa? Did she think it would? What is she looking for with this?
- 4. What do you think Janell's motivation is for searching out the accomplice? Is Natassa right? Is she trying to blame shift?
- 5. What good has God worked in Natassa's life from the tragedy she endured? What good has God worked in your life from your lowest moments?



CHAPTER FOURTEEN

- 1. Discuss the celebratory nature of harvest described in the beginning of this chapter. What mixed feelings does Mercy have about it? Why?
- 2. Did you know how enslaved people passed on African traditions to their masters? In what ways were the enslaved influenced by white culture? In what ways did they influence white culture?
- 3. What was your reaction to Mercy seeing Susan again? Do you think this friendship can survive their current circumstances?
- 4. Discuss the sale of enslaved people in the marketplace. How was dehumanization on display?
- 5. Comment on the significance behind the coins Mercy is given for the market. What all is connected with money for her? What does it represent?

CHAPTER FIFTEEN

- 1. Did you know that those who have a sex case are often persecuted by other prisoners? How do you feel about this?
- 2. Comment on the irony of having a cellie named Rob. What emotions does DeAndre experience around his old friend? Have you ever felt similar?
- 3. How did you feel about Reg's visit? Do you think his desire to clean himself up is sincere?
- 4. In this chapter, DeAndre reaffirms that turning himself in was the right thing to do, but wonders why, if that's true, it's so hard. Have you ever done something you felt God was calling you to do only to find out it was much harder than you anticipated? How did you react?
- 5. How is DeAndre's memory of and connection with his father affecting the choices he makes?
- 6. Discuss the line: Hope. How had he given someone something he didn't know he had to give? How did DeAndre spread hope in prison? How can you spread hope where you are?

- 1. How do you feel about Brandon's reaction to seeing Natassa in the paper? Was it justified?
- 2. *Healthy things grow.* How is Natassa growing in this story?
- 3. Contrast Natassa's style of hospitality with that of her mother's in book one. How are the two women different?
- 4. Have you or anyone you loved battled with infertility? How have you handled the *Why God* question?
- 5. *Hurt people hurt people*. Have you seen this play out in your life? How so?
- 6. How is being discriminated against because of one's uniform like being discriminated against because of the color of one's skin? How is it different?
- 7. Discuss the food visit. Would you have brought DeAndre a meal if you were Natassa? Have you ever felt God asking you to do something you were reluctant to do? What do you think it looks like to bless your enemies?

- 5. What is the significance of the service ending in communion?

- 1. What is your impression of Susan in this chapter? Why?
- 2. Comment on the irony of Phoebe waiting on Mercy. How do you feel about this?
- 3. She didn't understand that the tired I talked about had weight and length and breadth outside of a sore back and aching feet. It dug down deep into the soul... Can you empathize with this feeling in any way? How would you describe it?
- 4. What's the significance of Jonah doctoring Mercy's feet and bringing her shoes? What might it symbolize?

- 4. What feelings might you have been feeling if you were Natassa looking at the accomplice in your attack? How do you think you'd react?
- 5. What does the last scene in this chapter show us about Reg?

- 1. What are Jonah's positive qualities? How would you describe him to Mama?

- 3. If you were an enslaved person, do you think you would want to have children? Why or why not?

- 3. Discuss the tradition of planting lilies in place of gravemarkers. What is beautiful and heartbreaking about this picture of a graveyard?
- 4. Jonah expresses frustration over abiding by the master's rules and working his way up in the system only to have everything snatched away. How would this affect a person?
- 5. Discuss the change in Mama after finding out she and Mercy would be sold. Why do you think she's reacting this way?

CHAPTER TWENTY-THREE

- 1. Do you think it's understandable that Natassa feels Brett's death is her fault? Is it true?
- 2. Contrast Natassa's mother's "care" for the family after Brett's death with Bethany's. What might each "mama" represent?
- 3. Have you ever lost someone close to you? Did their home comfort you or rub you raw? Can you understand Laura's desire to get away from the place her husband should be but isn't?
- 4. What do you think of Natassa's offer for Laura to come live with them? Is it a good solution? Have you had people live with you before? How did it work out?
- 5. Do you know anyone who stuffs their emotions like Brandon? Have you seen someone break as described in the last scene?

- 4. What do you think of Susan's suggestion to purchase Mercy? How do you think that would have worked out for them? For their friendship?
- 5. How do you feel about Mercy's solution?
- 6. Mama admonishes Mercy to "remember who you are". Who is Mercy? What does she need to remember?
- 7. Discuss the concept of choice in the life of the enslaved. How did Mercy choosing to go to New Orleans empower her?

CHAPTER THIRTY-EIGHT


- How did becoming a mother to Mingo affect Mercy?
